## THE 2023 FELLOWSHIP THEME

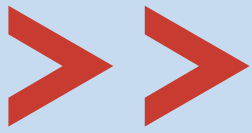

During our three weeks in Copenhagen, the 2023 CPH Fellow cohort will explore how we avoid losing sight of climate change amid all the present crises of the world today, how we can ensure democracy and human rights in a world of upheaval, and how we can avoid action turning into apathy.

Through workshops, discussions, and presentations by experts, politicians, NGOs, activists, and other actors in these fields, ***the purpose of the Fellowship is to equip Fellows with knowledge on how to engage with today's society's greatest challenges and to explore concrete ways of action.***

Nor is it intended to, in any way, limit a Network Member's rights to communicate with a government agency, as provided for, protected under, or warranted by applicable law. In addition, we understand that different terms mean different things in different contexts, languages, and countries. If you have any questions, please ask for clarification.

As in society at large, also in Humanity in Action's educational programs, and other ventures of the Humanity in Action community, situations that violate the organization's code of conduct can arise. Humanity in Action is committed to providing an open, respectful, and safe environment for its Fellows, Senior Fellows, Program Interns, Staff, Board Members, speakers, partners, and others involved in its programs. **Anne Katrine Ebbesen is our Ombudsperson**, our designated point of contact to serve members of the Humanity in Action network, including the Fellows of this program, who experience abusive, racist, sexist,

homophobic, or other forms of discriminatory behavior that emanate from other members of the network.

Senior Fellow (2013) and Lantos Congressional Fellow (2014), **Anne Katrine Ebbesen** is the ombudsperson for Humanity in Action Denmark. With a BA and MA in Rhetoric from the University of Copenhagen, specializing in minority studies, nationalism, and campaign analysis, she is also trained in conflict resolution and inter-religious dialogue from programs in Lebanon, Armenia, and Denmark. Anne Katrine is currently the Communications Officer at Nordregio, the Regional Research Institute of The Nordic Council and Humanity in Action Denmark Board Member.

# CREATING CONSTRUCTIVE DIALOGUE THROUGH COMMON VALUES

## GOOD AND CONSTRUCTIVE DIALOGUE

A good, open, and respectful dialogue is crucial for change and therefore crucial for Humanity in Action. Throughout the Fellowship we will work together to achieve good and constructive dialogues.

We communicate with each other all the time, therefore, how we communicate is central to the way we interact as human beings and how we function as a group. Together we will work to create the best possible foundation for good and constructive dialogue and communication - when we agree as well as when we disagree.

But what determines a "good" dialogue or a "good" conversation? A good dialogue and a good conversation can have many forms and we may interpret it in many different ways. Humanity in Action emphasizes an open and inclusive dialogue as an important value regarding "good" communication.

But what is it to you? In collaboration, you will define what good communication means to you, the 2023 Fellowship cohort, and you will create a foundation of common group values together.

## WHAT ARE VALUES -TO YOU?

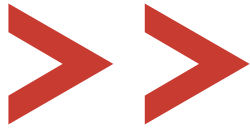
Values can be said to be culturally determined perceptions of what is valuable and desirable, and what is not.

Every human being lives their life based on their values which have often been determined in an early stage of life. Our day-to-day actions are influenced by our values, often without conscious awareness. These implicit values are shown through our interactions with others.

Values are more often than not implied and not necessarily mentioned explicitly but show themselves through our opinions and actions. Without explicit verbalisation, values are expressed through our communication and attitudes towards other people.

This can be expressed in the way we begin and end a conversation, how we listen, how we respond, if we are attentive towards the other person, and finally what words we choose when we speak with each other.

We are curious to know what values **you** would like to be present during the Fellowship in order to create open and constructive communication. Throughout the Fellowship, we will explore which values are especially important to you and how you would like them to be expressed in the way we communicate with each other.

# WHAT YOU NEED TO KNOW ABOUT

---

## FOOD



Lunch will be provided on all program days, and will be sensitive to individual dietary restrictions. When at Karens Minde, our main venue, lunch will be served warm and organic. When we are on tour, lunch may be sandwiches and the like.

You are responsible for your own breakfast and dinner. As well as all meals on days without programming. Some host families may provide breakfast and some dinners. Please refer to the individual host family to arrange meals.

## ACCOMODATION



Fellows from abroad are offered to stay with a host, a host family, a flatshare, or a dorm depending on availability and possibilities. This may vary from year to year.

Fellows are asked to be sensitive to their hosts' expectations, show openness to get to know the host and their families, as well as take part in the daily routines of the host and assigned chores.

People outside the Fellowship are not allowed to stay overnight in any Humanity in Action-sponsored accomodation without pre-approval from Staff, and where applicable, hosts.

## TRANSPORTATION



Fellows from abroad will be equipped with a travel card for public transportation. This will *not* cover all transportation during the Fellowship, only to/from the host family and location. Should you have any issues with getting to the locations, you may always contact the staff.

## LOCATIONS



The Copenhagen Fellowship will take place in several different locations in Copenhagen. It is your responsibility to check which location we will be at each day of your Fellowship. The location will appear in the day-to-day program.

Important! Fellows and staff must respect the spaces that we have been invited into.

We expect you will keep them in good shape and order, tidy up after yourselves, and be mindful of other activities that might take place in these locations while we are there.

# IMPORTANT PROGRAM COMPONENTS

---

## CHECK-IN & CHECK-OUT

These are important components of our everyday schedule. They will usually take around 15 minutes and are meant as spaces of transition where we prepare ourselves to either begin or end the day together.

They might sometimes include exercises inspired by meditation or mindfulness. You are welcome to come up with suggestions on how to start and end the day in a meaningful way.

*We expect you to be on time and ready every morning for our check-in.*

## GROUP DISCUSSIONS

We have set time aside for group discussions most days. We invite you to take turns in leading these discussions.

The aim is to provide a space for you to discuss the topics of the day in greater depth with your peers.

The discussions can also focus on topics you feel are missing from the program or on something you are passionate about.

Sign up at the beginning of the program to lead a group discussion.

## GROUP VALUES

We are in this space together, we are learning together and discussing with one another - sometimes emotional topics close to our hearts.

We will begin this Fellowship by exploring our values and determining our group values together.

E.g. How do we want to learn together in a respectful manner? What does respect mean to you? And what kind of behavior supports respectful listening? See above for more thoughts on values.

## SPEAKER PRESENTATIONS

We would like each of you to introduce a speaker before their lecture. Sign up for a speaker at the beginning of the program.

## LECTURES

Each day we will have lectures focusing on different aspects of our theme. The lectures will vary in length and style. Some will be more workshop oriented, others will be discussion oriented, but many will also be classical lectures.

## OPEN EVENTS

Some of our events during the Fellowship will be open to the public and friends of Humanity in Action. Please feel free to invite family and friends to these events. They can sign up for these events in a form that will be shared before the event takes place.

## ACTION PROJECT WORKSHOP

We have 2 workshops of 2 hours to inspire you to go from *passion* to *action*, and 2 hour towards the end of the program to further work on your project.

### Please NOTE:

On our first day at Ungdomsøen/Youth Island, we will ask you to **pitch your project idea** (1 min.) for the other Fellows.

## SENIOR FELLOW ACTION DAY

On June 23 - **Sankt Hans Aften** - we have a special afternoon and evening planned for you and our Senior Fellow community. The purpose of it is to bring you and our Senior Fellows together to connect and **strengthen your own as well as the Humanity in Action network.**

We will end with a dinner and a bonfire!



## BREATHING SPACES

On the second day of our Fellowship, we will introduce and guide you through a short meditation. We call the meditation **Breathing Space.**

This is a simple meditation that restitutes the brain and the body, which can be useful and soothing during the day or after a long day. Meditation can also help increase focus, concentration, and presence.

We will offer these meditations daily for those who find it soothing and helpful.

## GOODBYE DINNER

June 30 is our last day together. We will mark the end of our time together in Copenhagen with a dinner and a party at our main venue, Karens Minde Kulturhus.

We encourage you to make this day special and thus invite you to join in the planning of the dinner and party.

# ABOUT OUR VENUES

---

## OUR MAIN VENUE: KARENS MINDE KULTURHUS

*Karens Minde Kulturhus* (Karen's Memorial Culture House) is the place where we will be spending most of our days. Originally an asylum, the house now serves as a multipurpose space, often rented out as a venue for various events.

*Karens Minde Kulturhus* is located in Sydhavnen (South Harbour), a district in southern Copenhagen. Sydhavnen is largely a former working-class district and a less trodden path in Copenhagen, but has lately seen an architectural boom and now also contains upscale residential areas along the harbor as well as parks and recreational areas.

The place also houses a café and a library as well as green areas for us to work outside - if the weather allows for it - or just relax and hang out. There are even some animals.



## ANDELSGAARDE

"Andelsgaard" is a new cooperative movement with the aim of buying, rebuilding, and leasing farms to cultivate the land regeneratively in a modern and sustainable way. They work to mitigate the climate and biodiversity crisis and to produce more healthy food while giving more space to nature.

We will visit the association's first farm - Lerbjerggaard - located in Melby in North Zealand.

## CINEMATEKET

The Cinematheque is to film what libraries are to books. *Cinemateket* is a cinema placed in the center of Copenhagen that enriches film culture by keeping film history alive through the screening of historical films and cinematic cultural works. Humanity in Action hosts an Open Event at Cinemateket on June 19.

## HUMANITY IN ACTION DENMARK

At our Welcome Reception on June 8, you will get to see where all the magic happens! Our small office is located in a 17th-century building at *Christianshavn*. We share the space with a long list of other NGOs.

## THE TECHNICAL UNIVERSITY OF DENMARK - DTU SKYLAB

DTU Skylab is an innovation hub and a cross-disciplinary learning environment used by various institutes at DTU. Besides its 5500 square meters, complete with labs, workshops, auditoriums, open spaces, and project rooms, DTU Skylab offers soft funding, business acceleration, prototyping, and a space to grow for deep tech start-ups and pre-start-up projects. We will spend a day in their facilities and learn more about their research on "Technology - Leaving No One Behind".

## UNIVERSITY OF COPENHAGEN - SOUTHERN CAMPUS



On June 26 and 28, we will be hosted by the University of Copenhagen - Southern Campus (Søndre Campus). The University of Copenhagen is spread out in several different locations in the city, this part houses the Faculties of Law, Humanities, and Theology.

## UNGDOMMENS DEMOKRATIUS

We will have a couple of events at *Ungdommens Demokratibus* (Youth Democracy House), among others our Senior Fellow Action Day on June 23. It is a communal space for young people, and it is placed in Copenhagen's Meat Packing District, which is particularly busy at night with bars, restaurants, and places to dance.

## UNGDOMSØEN/ YOUTH ISLAND

On June 15-16, the Copenhagen Fellowship will take place at *Ungdoms-øen* (Youth Island), an Island located just a short ferry ride from Copenhagen. It is an old sea fortress from 1894. In 2015 it was acquired and donated to the Danish Scout Movement by The A.P. Møller Foundation and the Nordea Foundation. Youth Island aims to strengthen young people in their journey to become active, committed, and curious citizens.

We will spend the night there in rooms 4-8. **Remember to bring your swimming suit! (All meals, towels, and linen will be provided, but anything else you will need to bring from home as there are no shops).**

**It's not permitted to bring alcohol to the island.**

The Climate Academy

Anders Holst Bodin (he/him) is the leader and co-founder of The Climate Academy (Klimaakademiet). He works with leaders and change-makers to cultivate skills, mindsets, and communities for climate action. After finishing his ph.d. in physics and sustainable energy technologies in 2017, he has worked to develop a more holistic approach to climate action, integrating transformations in systems, cultures, subjectivities, and behaviors. In 2019 he published his first book 'The Roots of the Climate Crisis' (Klimakrisens Rødder), which connects philosophical, political, and scientific perspectives to develop visions for a more sustainable future. In 2020 he co-founded The Climate Academy, which he leads today. The Climate Academy develops workshops, courses and public speaking in order to empower people who wish to contribute to deeper climate action. He collaborates with e.g. University of Copenhagen and several Danish municipalities.

democratic backsliding in already established democracies. Why and how does it happen in practice? She has in her book *The Tribalization of Europe* (Polity 2020) shown how the breakdown of democracy takes place at a very concrete level through the law in countries like Poland and Hungary but has also in an article from 2022 in *Democratization* researched how difficult it is to measure democratic backsliding because different monitoring institutions see democracy differently. Wind has also focused on the more philosophical aspects of democratic decay for instance the balance between courts and parliaments and how the protection of the individual against the state became a cornerstone in the democratic development in Europe after the Second World War. Interestingly however not in Northern Europe where it is still 'politics' and the Parliament which is considered the only legitimate body to protect the citizen.

Lerbjerggård is managed by Nanna and Christopher, both graduates from Kalø Økologisk Landbrugs-skole. Nanna and Christopher are in charge of the farm's organic vegetable production, which provides more than 40 different types of vegetables and many more sorts. The crops are sown continuously, so there is a wide variety of freshly harvested vegetables throughout the season. In addition to vegetables, cut flowers are grown and forest farming has been established with around 500 trees and shrubs. As a principle, Nanna and Christopher strive to keep the soil continually covered – either with live plant roots or with other organic material to stimulate a living soil. Therefore, all vegetable beds are, as far as possible, sown with catch crops or covered with e.g. straw after harvest, so that they remain covered throughout the winter. The vegetable beds are also permanent and are cultivated with minimal tillage. The ambition is to build up the interaction between the living roots of the plants and a diverse population of organisms underground as well as above ground. Together they contribute to the storage of atmospheric carbon in the soil, and over time will build up the life, fertility, and biodiversity of the farm.

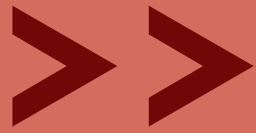

Humanity in Action is an international non-profit organisation that aims to instill the values of human dignity and moral responsibility in a new generation of social, cultural, and political leaders by:

- Engaging student leaders in histories of resistance to institutionalized violations of minority rights in democratic countries;
- Promoting the growth and development of young professionals dedicated to protecting human dignity and the rights of minorities;
- Building a multi-national, intergenerational network of present and emerging leaders in diverse professional fields who share these commitments.

Humanity in Action believes that an important test of a genuine democracy is how it treats its minorities, and that the commitment to democratic values and the protection of minorities cannot be taken for granted in the United States and Europe.
