# About the Training

The ability to mediate effectively and to communicate constructively is indispensable for anyone working in the realms of human rights protection, diversity and pluralism. It is precisely for this reason that Humanity in Action decided to invite members of its Senior Fellow community to Berlin to take part in this two-day training workshop on effective communication and mediation methods.

The training, which is led by an established mediator from the Netherlands, seeks to offer an opportunity for Senior Fellows to become acquainted with the most important methods of a successful mediator and communicator. Participants will get the chance to engage with the secrets of mediation and to develop their skills in handling conflict and communication, including how to use meta-communication or how to recognize their own and others' conflict patterns.

Humanity in Action selected a total of 25 Senior Fellows from a wide range of countries to form part of this initiative. Through their participation, Humanity in Action seeks to connect emerging leaders and to empower them with the knowledge, skills and tools to be civically engaged to fight social injustice, exclusion, and the discrimination of vulnerable groups in their home communities and around the world. To succeed in this endeavor and to continuously foster exchange and cooperation among the members of its network, Humanity in Action greatly looks forward to expanding its Senior Fellow training opportunities of this kind in the future.

# **Participant Biographies**



#### USMAN ASHRAF DENMARK

#### FRANCE

Laurène Bounaud has over six years of experience helping established and emerging leaders transforming their visions into actions. She holds a Master's degree in Communication from the Institut d'Etudes Politiques of Toulouse and a Master's degree in Political Science from La Sorbonne University in Paris. As a political assistant to a Member of the French parliament and then to the Deputy Mayor of the 19th district in Paris, she worked on issues linked to social cohesion and territorial inequalities. Serving communities often deprived of their right to a voice in the national debate, she stepped out of the political bubble and looked for new ways to mobilize and empower people. She was selected to the Humanity In Action Fellowship where she gained a deeper understanding of the mechanisms leading to discrimination, was introduced to concrete methodologies to foster social change and connected to an international network of link-minded peers. For the next 5 years, as coordinator and national director of the French branch of HIA, she actively contributed to the emergence of a new generation of social innovators in Europe and the United States. 
### RACHEL LANDRY UNITED STATES

# **Trainer Biography**



#### LENKA HORA ADEMA THE NETHERLANDS

Lenka Hora Adema, LL.M MOC is working as a self-employed senior mediation expert, facilitator and process designer, and organizational coach in The Hague (The Netherlands). She is specialized in (cooperation) disputes with and within organizations and governments. Lenka works regularly on projects abroad as an advisor in conflicts, a facilitating mediator and organizational coach. Born to an Armenian-Iragi father and a Dutch mother, her personal experience with different cultures is a treasure trove for her work. With two partners she started DoDemocracy.eu (DoeDemocratie.nu), an organization facilitating and organizing dialogue between citizens and governments, for example a dialogue about refugees in the Netherlands and what that means for neighborhoods. Lenka also works as a mediation trainer, teacher and assessor both in the Netherlands and abroad for one of the oldest institutes for mediation in the Netherlands, the Centrum voor Conflicthantering (CvC.nl). She is an editorial staff member of the specialist journal for mediators in the Netherlands, the Tijdschrift Conflicthantering (Journal for Conflict Management). Previously, Lenka worked as a lawyer and academic staff member at the Supreme Court of the Netherlands. During this period she worked for Lawyers Without Borders and as a board member of the Association for Law and Administration in Developing and Transition Countries.
