
MEP Claudiu Ciprian Tanasescu, S&D (Romania) Environment, Public Health & Food Safety; Culture & Education







My focus was on the (mis)representation of communities of color and other marginalized groups in the mainstream U.S. media, and the ways in which those representations could influence policymaking. After college my interest in media on a theoretical level and long-time involvement in various journalism projects led me to the PBS NewsHour. The NewsHour is a Washington, DC-based public television show dedicated to national and international affairs. I held a variety of jobs at the NewsHour, most recently as a Reporter-Producer, writing scripts and editing video for day-of-news stories. 
